That concerns the income in the second year preceding the year in which the application is submitted (T-2, also referred to as 'reference year'). You should also list your assets in that reference year. If you resided in the Netherlands during that year and if you earned an income there, you only need to mention your 'sofi-number' (tax and social insurance number).
